# Nonprofit Corporation

## ARTICLES OF INCORPORATION

The undersigned, acting as incorporator to form a corporation under the New Mexico Nonprofit Corporation Act, adopts the following Articles of Incorporation:

ARTICLE ONE: The name of the Corporation is: Revolution 120, Inc.

ARTICLE TWO: The period of duration is perpetual.

ARTICLE THREE: The purpose for which the corporation is organized is to help individuals and organizations serve charitable needs in New Mexico, primarily in Doña Ana County, New Mexico, with an emphasis on cultivating a culture of giving, particularly within the community's youth. The corporation is organized exclusively for charitable purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Aid may be through acceptance of donations of money, sponsorships, volunteer services, good or materials, and assisting in coordinating the efforts of other not-for-profit entities and government to serve unmet needs in the community, and will focus on a "pay it forward" model for participation.

Upon dissolution of the corporation, assets in the United States shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the U.S. Internal Revenue Code, or corresponding section(s) of any future federal tax code, or shall be distributed to the Federal Government, or to a state or local government, for a public purpose, in any case, for the benefit of New Mexico residents. Assets not in the United States shall be disposed of in accordance with the applicable law of the jurisdiction(s) involved.
